**Waiver Form**

Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement  
("Agreement")

1. IN CONSIDERATION of being permitted to participate in any way in Big Island Table Tennis Association sanctioned events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:
2. ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my child will immediately discontinue further participation in the Activity.
3. FULLY UNDERSTAND and (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inactions, or the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.
4. HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW;

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE BIG ISLAND TABLE TENNIS ASSOCIATION, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or minor child's behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

**ENTRANCE FEE:**

**Adults - \$20.00**

**Youth - \$10.00**

**TOURNAMENT RULES: Tournament will follow current United States Table Tennis Association rules. Matches will be to 11 points and best 3 out of 5; except in Open Division finals, which will be best 4 out of 7.**

**No hidden serves will be permitted. During service the ball must be tossed from an open palm a minimum of 6 inches. Before the start of play a tournament official will demonstrate a legal serve and answer any other questions regarding rules. Player may use only paddles and rubber, legal under USATT rules.**

**Unless time and space permits, players may enter only one division. Players wanting to play in more than one division should check with the tournament directors the day of the event. Open division players will not be permitted to play in other divisions.**

**Medals will be awarded for 1st, 2nd and 3rd place finishers in all divisions. Awards will be presented on tournament day and all contestants will receive a BITTA rating after tournament.**
