- [R] Current HTTC rating required to advance beyond round robin preliminary round unless approved by tournament committee prior to event.
- You may only enter one (1) event per group.
- Events with fewer than 3 participants (singles) or teams (doubles) will be canceled.
- Matches will be best-of-five, 11-point games. The semifinals and final of Over-1700 Singles event will be best-of-seven games.
- Orange Nittaku brand balls will be used for this event. (White ball is available upon request with agreement of both players only.)
- Orange colored clothing and black-soled shoes are prohibited. Exception: if a white ball is used, no white shirts are permitted to be worn.
- Pre-match warm-ups are limited to 2 minutes. Those desiring a referee may request one from the Control Desk.
- Awards will be given to the top two places in each event.

All players must check in with the Control Desk no later than 15 minutes prior to the scheduled starting time of their event. NO EXCEPTIONS. It is recommended that you allow for unexpected delays, especially due to traffic, etc.

Important: Please give us a phone number where you can easily be reach. We will be contacting you if any of your chosen events are cancelled due to lack of entrants. You will be able to select an alternate event.

Hawaii Table Tennis Club
Release and Waiver of Liability, Assumption of Risk, and Indemnity, and Parental Consent Agreement

IN CONSIDERATION of being permitted to participate in any way in Hawaii Table Tennis Club sanctioned events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.

2. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.

3. HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW;

4. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE HAWAII TABLE TENNIS CLUB, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

5. I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
